The growing number of patients experiencing homelessness is among the major challenges of our time. These individuals have complex needs that require multi-faceted solutions. For many of California's hospitals, addressing these needs is not a matter of will, but of strategy.

New Livestream Option

Livestream allows you to hear and view the seminar from the convenience of your own office or conference room. Plus, multiple people can experience the seminar with a single registration fee. Livestream tuition entitles the registrant to:

Continuing Education

To self-report, participants must log into their MyACHE account and select ACHE Qualified Education Credit.
